- Member may designate one individual (Designee) who may benefit from the same terms described in this application but will be limited to five discounted rentals or captained charters per calendar year. Member may change this Designee no more than once per year. The Designee must be requested by Member and approved by Sea Gate Boating in writing.
- Discounts depend on the membership level (Ambassador's, Admiral's, Commodore's) as specified above.
- Kayaks and stand-up paddle boards are discounted to a price of only \$10/each per day, for all membership levels.
- Commodore's Club Members half-day boat rentals are from dawn until 1 PM, or from 2 PM until dusk, during Daylight Savings Time
- Ambassador's & Admiral's Club Members can start their half-day boat rental period at any time in the daylight hours.
- Weekdays are defined as Monday through Friday, and not a national holiday, the day before the holiday, nor the day after.
- Applicant acknowledges that he/she has read the Sea Gate Boating rental contract for each boat. Applicant plans to operate and/or occupy. Member, and Member's Designee, must sign each boat rental contract and demonstrate sufficient boating knowledge and skills prior to operating the boat without Sea Gate Boating's assistance. A security deposit is required prior to departing in a rental boat as specified in each rental contract.
- Member or Sea Gate Boating may terminate this contract at any time with or without cause. Should contract be terminated, and providing Member's monthly fees are current, Member would be provided a full refund of the initial membership fee minus any discounts that had been applied to rentals, training or captained charters. Member's designee would no longer be eligible for discounts.
- There is not a limit to how many times the boats can be rented, however advanced reservations by Member and Designee is limited to fourteen (full or half-days) and no more than one national holiday. Once a reserved day is used, Member and Designee may continue to make additional reservations within these limits. Payments for those reservations are due in full immediately.
- Member is entitled to full credit for cancellations, minus a \$15 fee, provided notification is received by Sea Gate Boating 48 hours in advance of the rental period. Boat reservations may be cancelled without a fee, should a local small craft advisory be issued, or should precipitation be experienced in the first hour of the rental period.
- Monthly payments will remain the same price for three years following the date of this contract. Monthly payments are due the first day of each month. A late fee of 1.5% APR will be applied if payment is not made within 30 days of the due date. Member is not eligible for a boat rental, training or charter discount unless the monthly fees have all been paid.
- Applicant acknowledges that fleet, engines, accessories, locations, and rental prices are subject to change.
- This offering is open to all applicants without regard to race, color, age, sex, sexual orientation, religion, national origin, handicap, or marital or familial status.
- A receipt in the sum of \$_____ paid by Applicant to Sea Gate Boating, LLC, is hereby acknowledged as an initial payment for the Boat Club Membership. Applicant agrees to pay \$_____ on the first day of each month to retain the Boat Club Membership.
